

Tickets to Rapids v. Vancouver Whitecaps FC SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: Tickets to Rapids v. Vancouver Whitecaps FC is open to legal residents who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. By submitting your completed online entry form as directed, you will receive one (1) entry in the Sweepstakes.
