

## EA Sports FIFA 17 (XBOX ONE) SWEEPSTAKES OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** Win a EA Sports FIFA 17 for a Xbox one is open to legal residents who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry.
